Legal fees and other collections that shall be paid for filing of civil cases, special civil actions, special proceedings, cadastral and land registration cases, criminal cases instituted with civil liability, and supplemental/amended pleadings.

Assessment of Fees for Filing of Applications, Motions or Requests

Legal fees that shall be paid for filing applications, motions, and requests, which includes Application for Extra-Judicial Foreclosure, Application to Solemnize Marriage, Application for Notary Commission, Motion for

OUR SERVICES

Assessment of Fees for Other Services Rendered

Legal fees that shall be paid for other services rendered or to be rendered by the court, which includes service of summons, subpoena and other court processes, execution of writs, safekeeping of consigned money,
